## Explanation of Responses:

- This option is fully vested
- This share option vests over a four-year period: On May 15, 2008, 25% of the number of shares originally granted vested, and 6.25% of the original number of shares vest per quarter thereafter.
- These restricted stock units ("RSUs") vest over a four year period: 25% of the original number vest on the Exercisable Date shown in Table II and 6.25% vest per quarter thereafter.
- Each RSU represents Vistaprint's commitment to issue one ordinary share when the RSU vests.
