- The options were granted under the 2005 Non-Employee Director's Share Option Plan, as amended, pursuant to which each non-employee director of the Company automatically receives options to purchase Common Shares having a fair value (determined by the Black-Scholes method) of \$50,000, up to a maximum of 12,500 Common Shares, at each year's annual board meeting at which he or she serves as a director.
- Option and restricted share units vests as to 8.33% of the original number of Common Shares each successive three-month period following the grant date until the third anniversary of the grant date.
- The RSU's were granted under the 2005 Non-Employee Director's Share Option Plan, as amended, pursuant to which each non-employee director of the Company automatically receives RSU's having a fair value (determined by the closing price as listed on the NASDAQ Global Market on the grant date) of \$110,000 at each year's annual board meeting at which he or she serves as a director.
